As discussed with Eileen Hare of your company on July 17, 1990, the subject APD's are rescinded and returned due to drilling not being commenced within one year of the approval date.

If this office does not receive comment within 30 days, we will presume that no construction occurred and proceed accordingly. Later discovery that construction activities have in fact occurred, may result in assessment of liquidated damages.
