Gentlemen:

BHP Petroleum (Americas) Inc. respectfully requests that a non-standard location be approved to allow the GCU #56 to be recompleted in the Fruitland Coal formation. The well is located 1650' FNL and 990' FWL of Section 35, T-28-N, R-12-W in San Juan County, New Mexico.

The non-standard location is being requested so that the present acreage that is dedicated to the GCU #57 can be rededicated to the GCU #56. The GCU #57 was recompleted in the Fruitland Coal in 1992 but was uneconomical to produce and is now temporarily abandoned.

No additional surface damage is expected.

BHP is the operator of all offsetting proration units.

- 1.) Log well from casing shoe to surface to locate Fruitland Coal interval.
- 2.) Production test the Pictured Cliffs; if productive (25 MCF or more) set an RBP @ approximately 1,625'. If unproductive, set a CIBP @ same depth.
- 3.) Test casing and RBP or CIBP to 500 psi.
- 4.) Perforate the Fruitland Coal with 4 JSFP.
- 5.) Fracture stimulate w/a minimum of 40,000# of sand.

B.O.P.E. will consist of a 2000# preventor equipped w/pipe rams for the workstring, blind rams, and a non-rotating stripper head.


