01/20/94 - MIRU workover rig. Tested csg. and CIBP to 500psi. Perforated the Fruitland Coal from 1513' - 1525'. Ran 2-7/8" tbg. and set packer 1404'. Fractured well w/N2 foam and 45,920 lbs. of sand. Released packer and laid down 2-7/8" tbg. Ran 2-3/8" tbg. and landed at 1517'.
01/22/94 - Released rig. Flowed well back and tested. SI for buildup.
02/26/94 - Test: 120 MCFPD, FTP 24 psi., 0 BWPD.
