2. Shot and recovered 1 1/2" casing from 2950'.
3. Plugged 1100'/1000' with 25 cement.
4. Plugged across 6-5/8" shoe at 283' from 290'/2000' with 25 cement.
5. Plugged to surface with 20 cement.
6. Erected regulation abandonment marker. P & A 1000, 5/9/61.
