03/02/94 - MIRU workover rig. Tested csg. and CIBP to 500 psi. Perforated Fruitland Coal from 1272' - 1282'. Ran 2-7/8" tbg. and set packer @ 1175'. Foam frac'd well w/38,700lbs. of sand. Released packer and laid down 2-7/8" tbg. Ran 2-3/8" tbg. Cleaned out to PBTD. Landed tbg. @ 1274'. Released rig 3/4/94.
03/14/94 - Flow tested well. Test: 230 MCFPD, 3 BLWPD. Shut well in for buildup.
