In reference to our Form 9-331 of December 16, 1965, we plan to permanently abandon the subject Southeast Cha Cha Unit Well No. 28 as follows:

1. Spot 125 sacks cement containing 62 Gal from PMS 5801' to approximately 4400' and squeeze. (Theoretical fill = 75 sacks)
2. Load hole with fluid and spot 70 sacks (61 Gal) from 3800' to 2800'.
3. Load hole with fluid and spot 18 sacks (61 Gal) from 300' to 400'.
4. Pump 80 sacks (61 Gal) down 2-5/8" - 4-1/2" casing annulus.
5. Load hole with fluid and spot 5 sacks (61 Gal) surface plug, out off wellhead, erect abandonment marker and clean up location.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
