As a result of the Gallegos Canyon Unit No. 101 ceasing to produce, we plan to plug and abandon the well as follows:

1. Spot 40 sacks cement containing 6% Gel and 2% calcium chloride from PWD 5400' to about 5400' (Perf 5547') and squeeze.
2. Load hole with fluid and spot 75 sacks cement containing 6% Gel and 2% calcium chloride from 4260' to 2700'.
3. Load hole with fluid and spot 10 sacks cement from 1350' to 1250' (stage cementing tool at 1886' - 145 sacks 4% Gel Incer cement - estimate 600' fill).
4. Load hole with fluid and spot 5 sacks cement (6% Gel and 2% calcium chloride) from surface to 50'.
5. Pump 50 sacks cement (6% Gel and 2% calcium chloride) into 8-5/8" - 4-1/2" casing annulus.
6. Cut off wellhead, erect PXA marker, and clean up location.

## Instructions

**General:** This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

**Item 4:** If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

**Item 17:** Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
