We propose to convert the subject well to water injection into the "A" zone of the Gallup. A bridge plug will be set above the "B" zone at 5735' and two sacks of cement will be dumped on top of the plug. A packer will be set at about 5590' on 2-3/8" tubing and the water will be injected between the packer and bridge plug into the "A" zone perfs at 5691-98'.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
