On April 20, 2000, Amoco Production Company filed a request to maintain the subject well in a shut-in status pending evaluation of returning the well to production status, possible uphole recompleation potential or recommendation for plugging and abandonment. It has now been determined that the well should be plugged and abandoned. Plugging operations are being formulated and well be submitted to your office in approximately 60 days. Plugging operations will be initiated upon regulatory and partner approval.
