On November 28, 2000, Amoco Production Company submitted a Sundry Notice indicating that the subject well was a candidate for plugging and abandonment and that plugging procedures were being formulated to submit for your approval. Amoco has since instituted a policy whereby each wellbore will be more closely reviewed to determine if an attempt may be made to restore it back to production status either in the existing zone or uphole and avoid premature abandonment of possible reserves. Amoco, therefore, request permission to maintain this wellbore in a shut-in status pending the wellbore review which we anticipate will be completed for all wells in the San Juan Basin in the 4th quarter of this year. If review indicates no potential exist for this well plugging procedure will be submitted for your approval.
