1. MIRU PU. Set 4-1/2" RBP @ 6,300' to isolate the DK perforations.
2. Perforate the Gallup fr/5,828' - 5,846' and 5,886' - 5,896' with 2 JSPF.
3. Frac Gallup perforations.
4. Flow back well until clean.
5. Produce Gallup formation until rates stabilized.
6. Obtain downhole commingling approval and downhole Gallup and Dakota formations.
