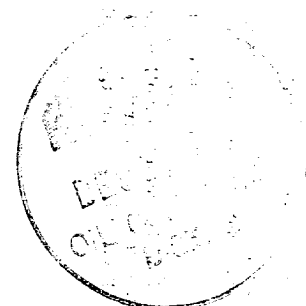

32#, K-55, R-3, ss, new casing set at 133' (K.B.). Cemented w/65 sx  
of regular cement w/3% CaCl2. Plug down at 6:00 P.M., 12-11-76.  
Good Returns. Nippled up and pressure tested BOPE to 400 psi. Held  
O.K. Drilled out w/7-7/8" bit at 4:00 P.M., 12-12-76.
