Plug #1 1300' to 879, 32 sxs, TOH w/tbg, RIH & perf @251'. Press up to 800 psi. no rate, TIH w/tbg to 313'. Plug #2 313' to 163', 12 sxs, TOH w/tbg, RIH & perf @85'. Plug #3, 85' to surface 20 sxs. Bullhead, nipple down BOP, cut off well head, install dry hole marker.
