- 1. Clean and true up pit with back hoe.
- 2. Cover bottom of pit with Aqua gel to stop water loss by seepage.
- 3. Line pit with 6 mil black plastic and cover with thin cover of dirt to stablize plastic.
- 4. Work will be completed with in 45 days of approval of this proposal.

The pit at the referenced well is leaking again. Weather has deteriorated the plastic liner and the Aqua-gel is not adequate to contain the water.

Within 60 days, submit a plan to this office for replacing the pit.

This well produces a significant volume of water but you have not shown any water production on your C-115's. Please correct that oversight on all future reports.

Our field inspection found that water is leaking around the polish rod stuffing box. Please have this repaired immediately.
