Dear Mr. Kolbe:

Reference is made to your application dated October 25, 1994 for a 271.32-acre non-standard gas spacing and proration unit consisting of the following acreage in the Basin-Fruitland Coal (Gas) Pool:

SAN JUAN COUNTY, NEW MEXICO
TOWNSHIP 28 NORTH, RANGE 12 WEST, NMPM
Irregular Section 10: All

It is our understanding that this unit is to be dedicated to your existing Gallegos Canyon Unit Well No. 295 (API No. 30-045-23995), which was drilled in 1980 and completed in the West Kutz-Pictured Cliffs Pool at a standard gas well location 1045 feet from the South line and 1075 feet from the West line (Unit M) of said Section 10, by Division Administrative Order NSP-1170, dated November 28, 1979, a 135.93-acre non-standard gas spacing and proration unit in the Pictured Cliffs interval was established and dedicated to the subject well.

It is also our understanding that the Pictured Cliffs zone will be properly plugged back and said well will be recompleted up-hole into the Basin-Fruitland Coal (Gas) Pool, which pursuant to the Special Rules and Regulations for the Basin-Fruitland Coal (Gas) Pool, as promulgated by Division Order No. R-8768, as amended, is standard.


