GIH & set BP pumped through bottom in FN. MIRU Big A #18. ND WH & NU BOPs. PT-OK. GIH & cleaned out fill. COOH & 92 jts tubing. GIH to pull 5-1/2" liner. Had to chemical cut liner @ 3075'. Fished and milled on liner to retrieve. Circ. hole clean.

GIH w/underreamer & underreamed open hole section from 3004' to 3172' from 6-1/4" hole to 9-1/2". COOH w/underreamer. Ran Sonic log. RIH w/super cavity tool (SCT) to 3021'. COOH. GIH w/6-1/4" bit & tagged fill. Cleaned out w/air mist & foam sweeps. GIH w/SCT & mined coal interval from 3100' - 3107'; 3112' - 3120'; 3126' - 3142'. Cleaned out to 3142'. COOH w/SCT. GIH & tagged fill. Circulated wellbore clean w/air mist for 13 days. COOH.

RIH w/2-3/8" 4.7# tubing and set @ 3090' with "F" nipple set @ 3055'. ND BOP & NU Bonnett & pumping tee. Run rods and pump. RD & released rig. Turned well over to production department to return to production.
