Plans are to TA the Dakota zone on the subject well. The Dakota production had dropped off dramatically. We have determined the best fix for this well will be to TA the Dakota zone and flow the MV only. Phillips has 100% interest in the Dakota interval. Details of the procedure we will be using is as follows:

LO/TO location. MIRU Key Energy. Kill well w/KCL water. ND WH & NU BOP. COOH w/tubing. RIH w/Baker N-1 CIBP & set @ 6050'. COOH. Re-run production tubing. ND BOP & NU WH. PT. Pump off expendable check. RD & release rig. Turn well back over to production as a MV well only.
