Run 1" tubing down annulus. Cemented thru 1" to top out with 50 sx (70 cf - 12.46 bbl slurry) Type 3, 2% CaCl2 mixed at 15 ppg, 1.41 yield. Had 1/2 bbls (2.8 cf) good cement to surface. NU BOP.
