Phillips will be DHC'ing the Mesaverde and Dakota intervals of the subject well per Order # 11363. Production will be reported using the subtraction method for 12 months and then convert to the ratio method for the life of the well. The Dakota forecast for the next 12 months is as follows:

1st month - 5369 mcf	2nd month - 5337 mcf	3rd month - 4971 mcf	4th month - 4958 mcf
5th month - 4790 mcf	6th month - 4483 mcf	7th month - 4490 mcf	8th month - 4170 mcf
9th month - 4185 mcf	10th month - 4069 mcf	11th month - 3576 mcf	12th month - 3857 mcf

The original Reference Case where Partner notification was made was R-11187. Dakota perfs are between 7547' - 7644' with a pore pressure of 2041 psi. The Mesaverde perforations are between 4991' - 5527' with a pore pressure of 575 psi. The value of production will not decrease by commingling. Also 100% of liquids allocations is to the Mesaverde. The BLM will receive a copy of this notification also.
