Pumped 10 bbls KCl water and 10 bbls gel water & 10 bbls water ahead of 1st Stage Lead - 150 sx (319 cf - 56.81 bbl slurry) Class H, 35:65 POZ 6% Bentonite, 10#/sx CSE, 0.3% CD-32, 0.2% FL-52, 5#/sx Gilsonite, 0.25#/sx Cello-flake. Tail - 50 sx (63 cf - 11.21 bbl slurry) Class H, 0.3% F1-25, 0.25#/sx Cello-flake, 5#/sx Gilsonite. Displaced w/124.5 bbls H2O. Plug down @ 1325 hrs 1/8/01. Pressured up to 2000# to inflate packer. Dropped DV tool & opened w/1400 psi.

Cemented 2nd Stage with 10 bbls KCl water, 5 bbls dye water ahead of Lead - 85 sx (164 cf - 29.20 bbl slurry) Class H, 35:65 POZ, 3% KCl, 0.4% F1-25, 5#/sx Gilsonite 0.25#/sx Cello-flake, 10#/sx CSE, 0.02#/sx Static free. Tail - pumped 50 sx (70 cf - 12.46 bbl slurry) Type 3, 0.25#/sx Cello-flake, 1% CaCl2. Displaced w/83 bbls H2O. Plug down @ 1450 hrs 1/8/01. Float held. ND BOP & set slips and cut off casing. RD & released rig 1/8/01. Will indicate TOC for 4-1/2" casing and PT on next report.
