ND BOP & RD equipment. RU Blue Jet & ran GR/CCL/CBL from 6245' (PBTD). TOC @ 3820'. Load hole & PT casing to 500 psi-30 min. Good test. Perf'd Menefee interval @ 1 spf .36" holes as follows:

RD flowback equipment and connect lines to sales. Plans are to flow this well for a couple of months and then return and complete the upper MV intervals before running the tubing and reconnecting well to sales.
