DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

The well was spudded at 10:00 A.M., October 23, 1953. On October 23, 1953, 9-5/8" casing was landed at 264 feet and cemented with 190 sacks of cement. Cement plug down at 11:22 P.M., October 23, 1953. At 11:30 A.M., October 25, 1953, casing and water shut-off was tested at 800 pounds for 30 minutes, with no drop in pressure. Forty-two feet of solid cement were drilled in bottom of pipe and water shut-off was again tested at 800 pounds for 30 minutes. There was no drop in pressure during this test and drilling operations were resumed.
