Gentlemen:

Reference is made to your application for approval of an unorthodox well location for your State Gas Unit "L" Well No. 1, to be located 1900 feet from the North line and 1100 feet from the east line and in the SE/4 NE/4 of Section 2, Township 29 North, Range 9 West, Blanco Mesaverde Pool, San Juan County, New Mexico.

It is our understanding that this unorthodox well location is based upon extreme topographic conditions in the NE/4 of said section.

Inasmuch as you furnished waivers from the offset operators, it is possible for immediate approval to be granted. Therefore, by authority granted me under provisions of Section 1 (c) of the Special Rules and Regulations of the Blanco Mesaverde Pool, as set forth in Order R-110 as amended by order R-397, you are hereby granted an exception to Section 1 (c) of Order R-110 as amended by Order R-397, for the above described unorthodox well location.

Reference is made to your application for approval of an amendment to the location for your State Gas Unit "L", Well No. 1, to be located 100 feet from the North line and 100 feet from the East line and in the 2 1/2 N., 10 E., Township 2 1/2 North, Range 9 West, Blanco Mesaverte Pool, Santa Fe County, New Mexico.
