Rig up, spud 3/22/66, drill w/Rotary to 137'. Ran 4 jts. 8-5/8" 24 J-55 GR casing set at 135'. Cement w/100 sx. Re-cemented w/50 sx from surface. WOC. Drilled cement and drilled to TD 2326' on 3/25/66. Logged, ran 13 jts. 3-1/2" O.D. 7.7# J-55 10R casing set at 2322'. Cemented w/200 sx, followed by 50 sx. WOC. Temperature survey shows top of cement at 75'. Released rig 3/25/66. Now waiting on completion rig.

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
