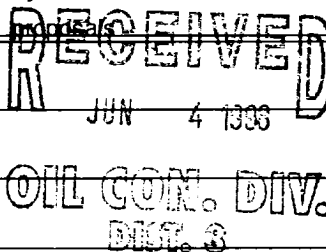

In June 1996 the Lewis Shale pay was added to the existing Mesaverde interval. A packer & sliding sleeve were placed in the tubing across the Lewis Shale interval for testing. The packer and sliding sleeve have now been removed. Details are as follows:

5/22/98

MIRU Big A #29. Closed sliding sleeve and set plug in "F" nipple. ND WH. Installed BPV & NU BOPs. Unseat packer and COOH with packer & tubing. RIH w/2-3/8" tubing and cleaned out to 5675' (PBTD). Landed tubing @ 5538' with "F" nipple @ 5505'. ND BOP & NU WH. Pulled BPV & PT to 1000 psi - OK. Pumped off check. RD & MO 5/23/98. Turned well over to production department.
