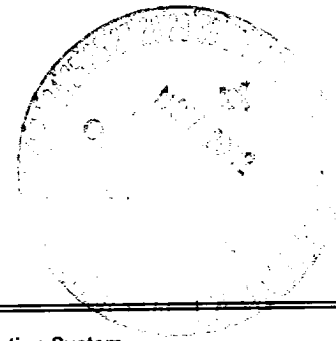

This well will be refraced as follows:

1. MIRU. TOH w/tubing.
2. TIH w/bit and drill out to top of liner hanger. Circulate hole clean. Pressure test casing to 3000 psi. TOH.
3. RU wireline and selectiavely perforate Pictured Cliffs from 4318'-4520'.
4. TIH w/packer and 3-1/2" workstring to 4300'. Fracture treat PC with a 70Q foam.
5. Flow back for cleanup. TOH and lay down frac string.
6. TIH and clean out to PBTD. Land tubing at bottom perforation.
7. Run pump and rods. Install pumping unit and return to production.
