1. MIRU. TOH and lay down 1 1/2" tubing. Release packer and TOH.
2. Run CIBP and set at 8700'. Cap plug with 15 sks cement. TOH.
3. Run 2 3/8" tubing set at 6700'. Return Mesaverde to production.
