RIH w/6-1/4" bit & tagged cement @ 3252'. PT 7" casing, rams. & valves & manifold to 200 psi - 3 min and 2000 psi for 10 min. Good test. Drilled cement to 3300' then new formation to TD @ 3495'. TD reached 4/7/99. COOH. RIH w/9-1/2" underreamer. Underreamed from 3302' to 3478' to a 9-1/2" hole. Circulated hole. COOH. Rotated and reciprocated w/air, mist foamer & 3 bbl water sweeps surging well for approx. 11 days cleaning out to TD. COOH laying down DP & DC & BHA. Land donut w/2-3/8" expendable check & 1 jt of 2-3/8" tubing under donut. ND BOPs. NU WH. Test - OK. RD & released rig 4/20/99.
