RIH w/7" 20#, J-55 casing and set @ 4160'. RU to cement. Pumped 20 bbls FW & 10 bbls mud clean & 20 bbls FW w/red dye ahead of lead cement - 510 sx (1274 cf - 226.9 bbl slurry) Type 3 cement, 35:65 POZ w/5#/sx Gilsonite, 1/4#/sx Cello-flake, 6% gel, 10#/sx CSE, 3% KCL, 0.4% FL-25, 0.02#/sx Static Free. Pumped tail - 50 sx (70 cf - 125 bbl slurry) Type 3 w/1/4#/sx Cello-flake, 1% CaCl2. Dropped plug & displaced with 166.6 bbls FW. Plug down @ 1527 hrs 6/26/00. Held. Circ. 5 bbls cement to surface. WOC.

ND BOP & set slips and cut off casing, rams, and manifold to 200 #-3 minutes and 3000 # for 10 minutes. Good test.
