Pumped tail - 50 sx (70.2 cf - 12.5 bbls slurry) Type 3 cement w/1/4#/sx Cello-flake, 1% CaCl2. Dropped plug and displaced w/124 bbls FW. Plug down @ 0618 hrs. Circulated 26 sx (11 bbls - 61.8 cf) cement to surface. ND BOP, set slips and cut off 7" casing. NU WH. PT 200# 3 minutes and then 2000# 10 minutes good test.
