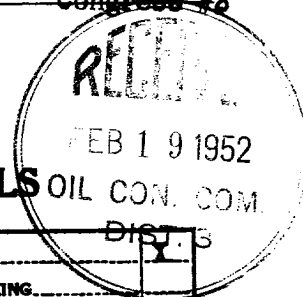

DETAILS OF WORK

Rotary total Depth 1941. Hole was reduced to 4-3/4" at 1756.
5-1/2" casing was cemented at 1845 with 75 sacks. Cable
tools moved on and drilled cement plug January 31, 1952.
Swabbed hole dry. Tested with 500# pressure for two hours,
hole dry and pipe O.K.
