

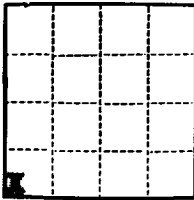

DETAILS OF WORK

We propose to drill subject well as follows:

1. Rotary tools from surface to total depth.
2. Drill 12-1/4" hole to 150'.
3. Run and cement 8-5/8" casing to 150'. Circulate cement to surface.
4. Drill 7-7/8" hole to total depth, approximately 2875'.
5. Run EM-Resistivity and Gamma Ray Sonic logs.
6. Run 4-1/2" casing below Gallup pay zones, run stage collar and cement in two stages. First stage - 140 sacks 9070 Ponnix; tail in with 90 sacks 9070 Ponnix. Second stage - 90 sacks 9070 Ponnix.
7. Potential well and clean location.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.

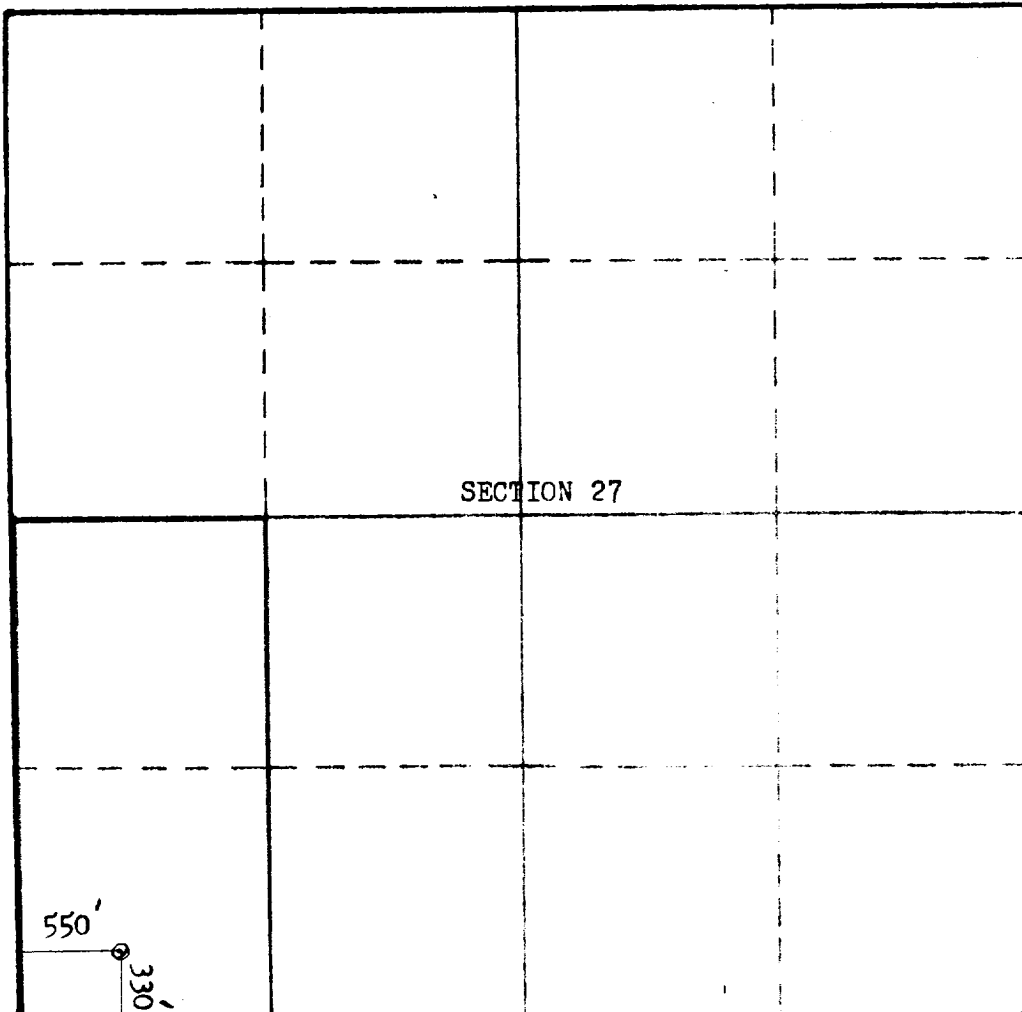
