On May 19, 1999, we submitted a request for permission to recompleat the subject well from the Basin Dakota into the Basin Fruitland Coal Pool. Approval was granted on May 26, 1999. s of this date the subject recompleation has not been performed. A recent review of uphole potential indicated that the Fruitland Coal would not produce the results desired and that a recompleation attempt into the Otera Chacra would prove more productive. A procedure to recompleat is being formulated and will be submitted to your office for approval within 60 days.
