1. Cut tubing @ 5164'. Pull out of hole 105 joints (3300')
2. Trip in hole with overshot to 1764'. Trip in hole with bull plug and perforate sub to 2047'. Trip in hole open-ended to 3150'.
3. Displace and balance, 110sx, 130cf, 3200'-1600'
4. Displace and balance 50sx, 59cf, 1600'-700'
5. Perforate @ 371'. Circulate 80sx, 95cf to surface.
