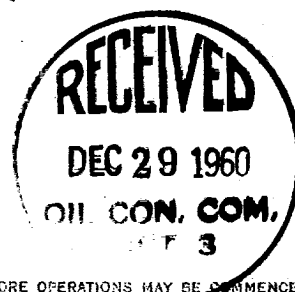

Perforate 4 1/2" csg from 5390-5400' w/2 shots per ft. Frac perf from 5390-5400' w/40,000 gal lse oil and 30,000# sand, avg inj rate 27 BPM. Clean out to 5447'. Ran 2" tbg set at 5394'. Swabbed well off. All load oil recovered 9-10-60. On potential test 9-13-60 well flowed 241 bbls PLO on 20/64 choke.
