In attempting to plug well per Sundry Notice dated May 7, 1970, was unable to pull tubing out of packer set at 6612'. Cut off tubing at 6597'. Latched onto stub and jarred for four hours and unable to free tubing. Now plan to spot cement plug from 6597-5000' instead of squeezing perforations.

Instructions
