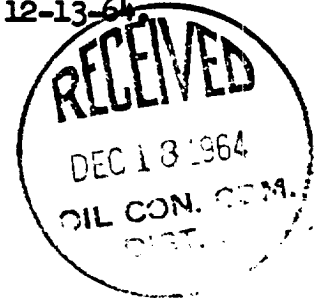

12-6-64 Rig up workover. Pulled 1" tubing. Clean well out. Ran 80 joints 3-1/2" casing set at 2011' GL. Cemented with 110 sacks, Class "C" cement 6% gel 2% calcium chloride 1/4 lb floccle mixed. Squeezed 20 sx through holes in Fruitland zone. Perforated at 1922 to 37 2 shot per foot. Frac with 10,000# 20-40 sd and 10,000# 10-20 sand FR-8 6# per 1000. 15,750 gal. water. Ran 90 joints of 1" tubing set at 1894. Date of completion 12-13-64.
