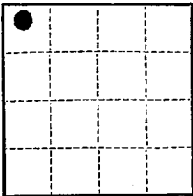

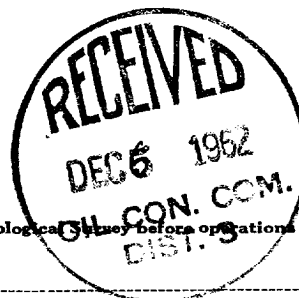

Drilled to 221'. Set 7 jts. of 8-5/8" OD 2 1/2" J-55 S Rd. Tnd. casing with 8-5/8" Baker Toms Pattern shoe on bottom of first joint with Baker Insert Float Check Valve in top of first joint. Casing set at 221' KB. Cemented with 200 sac regular Neat cement with 2% calcium chloride. Good returns to surface. Job complete at 12:45 p.m. 11-24-62.
