Southland Royalty Company requests administrative approval for both the non-standard unit and the unorthodox location of the subject well.

The non-standard unit is shown on the attached C-102 form as the NE/4, NW/4 and SW/4 of the SE/4 of Section 18. The SE/4 of the SE/4 is dedicated to the McDaniel #1 located in the NE/4 of Section 19 at 230' FNL & 280' FEL. (The McDaniel #1 was drilled in 1941 and the current acreage dedicated to it in 1955.) The non-standard unit of the McDaniel #1 is responsible for the non-standard unit of the Cozzens #7.

There is no orthodox location for the requested non-standard unit; therefore, we request administrative approval of the unorthodox location.

Southland Royalty Company is the operator of all offset proration units as can be seen on the attached map.




