Date: 11/9/98 Catch plunger, bleed off csg. RU pump lines. Kill tbg. w/ 5 bbls.. ND wellhead, NU BOP.Back out lockdowns and pull out hanger. Pickup 1 jt. tag fill @ 6575'. TOOH w/ 2 3/8" tbg. tallying out. Secure well for the night. *** Note: after releasing donut, had to pull weight on tbg. to get it to move. Appears that there may have been a bridge between zones. Tbg. looked good, no sign of scale.
