Spud a 12-1/4" hole on 6-3-84. Drilled to 335'. Set 8-5/8", 24#, K-55 casing at 335' and cemented with 360 cu. ft. Class B with 2% CaCl₂. Circulated cement to surface. Pressure tested casing to 850 psi. Drilled a 7-7/8" hole to a TD of 2858' on 6-8-84. Set 4-1/2", 10.5#, J-55 casing at 2841'. Cemented with 924 cu. ft. 50:50 poz, 6% gel, 2#/SX T plug and tailed in with 118 cu. ft. Class B Neat. Circulated to surface. No DV tool was set. The rig was released on 6-8-84.
