Amoco Production Co. requests approval to amend the casing program on the Application for Permit to Drill. The purpose for the change is to accomodate for dually completing the well. A conductor string of 13 3/8" casing will be set at 114' and cemented with 177 cu. ft. Class B Ideal. The 8 5/8", 24#, J-55 surface casing will now be 9 5/8", 36#, K-55. The 7 7/8" hole will now be an 8 3/4" hole and 4 1/2", 10.5#, K-55 casing will now be 7", 23#, K-55 casing.
