Gentlemen:

We hereby request a nonstandard location for a well to be drilled $\underline{315}$ feet from the North line and $\underline{387}$ feet from the East line of Section 22, T29N-R1lW, San Juan County, due to topographical conditions.

Any standard location in the North half of the Northwest quarter sectionwould be too close to residential housing and would violate the City of Bloomfield ordinance which required that no well can be drilled within 300 feet of a residence. The City of Bloomfield has grown so much recently that only a narrow strip approximately 160 feet wide and 800 feet long could meet that requirement. The proposed location is within that narrow strip.

Copies of this application are being sent by certified mail to all offset operators of wells which are completed in the Chacra formation. The names and addresses of all these operators are shown on an attached sheet.

Also enclosed are the well location plat and an offset ownership plat.


