Texaco E. & P. Inc. proposes to lay a water gathering line on the subject lease. This line will stay within the bounds of the lease and will service only wells on this lease. This line will begin in the SW 1/4, SW 1/4 of Sec. 23, T29N-R12W and end in the SW 1/4, NE 1/4 of same section. This line will parallel the access road to minimize disturbance.

- Materials will be a wrapped 2" schedule 40, steel line pipe. Connections will be welded.
- Approximate length of total system will be 5610'.
- Pipeline will be marked.
- All road crossings will be marked and buried a minimum of 24" under the road surface.

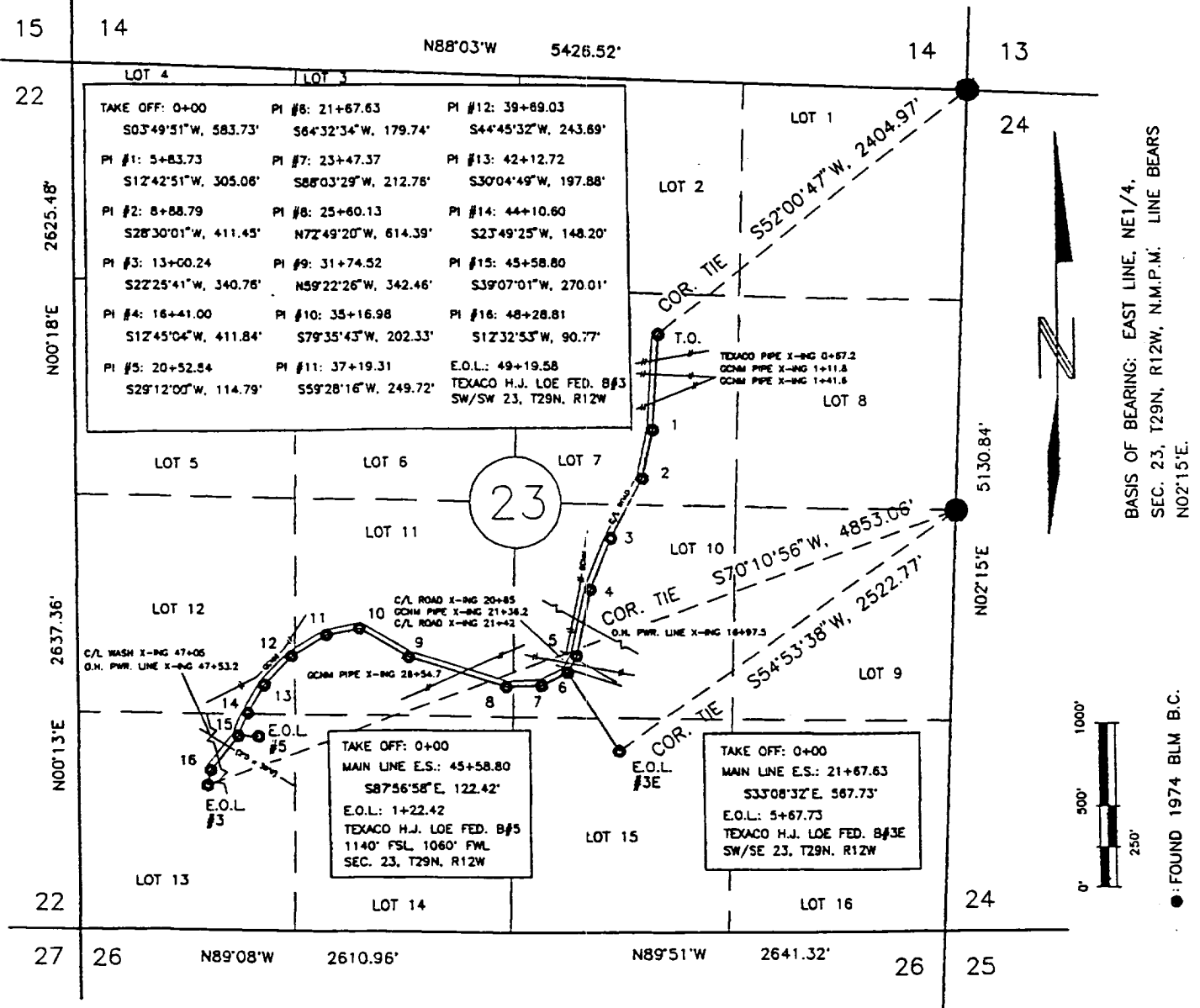

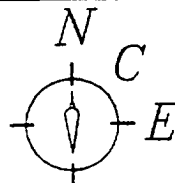
