
Change surface casing to 8-5/8" 24 lb/ft. in 12-1/4" hole. Cement with 100 cu. ft. Class B.
Circulate to surface.

Change production casing to 5-1/2" 14 lb/ft. in 7-1/8" hole. Cement with 150 cu. ft. 2% Lodense,
tail with 150 cu. ft. Class B. Circulate to surface.

All other aspects of application remain unchanged.
