This APD is to deepen the San Juan 31-6 #234 - Fruitland Coal seam to a the Pictured Cliffs formation. POOH w/2-3/8" tubing. Drill 6-1/4" hole from 3468' to new TD of 3700'. Run open hole logs. Run and cement a 4-1/2", 11.6#, N-80 liner (3000 - 3700). Perforate Pictured Cliffs formation. Fracture stimulate. Flowback to cleanup. Run 2-3/8" 4.7#, J-55 production string from surface @ 3650'.

A workover pit may be required. The BOP equipment schematic is attached. The original BLM stips are attached to a copy of the original Fruitland Coal APD for reference.

Note - The field and pool change from Undesignated PC to Wildcat Fruitland Sand PC. This is the only change made to the APD submitted 5-2-95.
