MIRU Basin Well Service #4. ND WH, NU BOP's. POOH w/2-3/8" tubing. Tag up @ PBDT @ 3355'. Tubing landed @ 3312'; strap out. PU 7" Packer Type BP & set 2995'. Load hole w/2% KCL H₂O-80 bbls. PT casing between pkr & B Plug (OK). TOH w/pkr, B Plug & 2-3/8" tubing. TIH w/2-3/8" tubing & 4-1/2 bit and tag PBDT of 3325'. TOH w/2-3/8" tubing and lay down 4-1/2" bit PT flowlines, blind rams (OK). Install isolation tool to Frac. RU Western to frac. Frac well via 7" casing w/5-1/2" liner w/70 quality foam w/30 # gel pumped, 160,310 # 16/30 Brady Sand. Avg. treat pres 2850, avg rate @ 70 BPM; max pressure 4390, flushed w/98 bbls of gelled H₂O. Total fluid pumped 677 bbls, total N₂ pumped, 1467,982. Forced closure flowback on 1/8" & 1/4" fixed positive chokes. ND treesaver. Tip in hole w/2-3/8" tubing, tag sand fill. Unload well and clean out with air, H₂O mist and soap mist. Also, used bailer to clean out. TIH w/2-3/8 tubing, exp check, 1 jnt tubing, F-nipple and landed at 3060' and gas lift mandrel set at 2210'. Flowed well thru 1/4" choke up tubing. RD and released Rig. SI tubing pressure 1050, SI Casing Pressure 1150. Gas Rate 180 MCFPD, Water 100 BWD.
