Total N2 used 1,810,000 scf. ATR - 60 bpm, ATP - 4000 #, ISIP - 3355 psi. Flowed back on 1/4" and 1/2" chokes. Killed well w/KCL. RD flowback equipment. RIH w/tubing and cleaned out fill to 5915' (CIBP). PU & lamed 2-3/8" 4.7# tubing @ 5673' w/"F" nipple set @ 5730'. ND BOP & NU WH PT - OK. Pump off expendable check. RD & released rig 10/14/00.
