Drilled to 3827'. Circ. & cond hole. RIH w/7" 23#, J-55 LT&C casing and set at 3828'. RU Western and cemented with 500 sx 65:35 POZ Class "B" cement w/12% Bentonite gel & ¼#/sk celoseal 12.0# p/gal, 21.8 ft p/sk & 150 sx Class "B" cement w/2% CaCl₂ & ¼#/sk celoseal, 15.6 ppg, 1.18 ft p/sk. Did not bump plug, circ 10 bbls slurry to surface. (cemented at 2200 hrs on 10-21-93). WOC 4 hrs. ND & set slips. NU & tested BOPs.

Drilled to T.D. 8175'. Logged Well. Circ & cond hole. RIH w/4½" 11.6#, N-80 casing. and set at 8174'. RU Western to cement. 20 bbls mud flush ahead & 10 bbls water before cement. Cemented w/225 sx 65:35 POZ w/12% gel, 2% CaCl₂ & ¼#/sk flocele. 21.8 yield, 12 ppg & 150 sx Class "B" w/2% CaCl₂ & ¼#/sk flocele. (cemented at 0300 hrs on 10-29-93). Plug down @ 4 hrs. Est. cement top @ 3400'. 6 bbls short on displ. (pumped 120 bbls disp. 6 bbls short of required disp. formation locked up - shut disp down @ 3000 psi), 387' cement left in casing. ND BOPs, set slips, cutoff casing. RD & released rig. Waiting on completion rig.

GENERAL INSTRUCTIONS

This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
