We request continued temporary abandonment status for this well. The Dakota formation is uneconomic and was plugged with cement on January 4, 1994. Currently a sales line to this well is unavailable. Seasonal closures in the Rosa Unit will prevent work during the winter. Williams Production Company plans to evaluate this well for recompletion to the Mesaverde formation in 1997, along with our 1996 drilling program.

ROSA UNIT #131

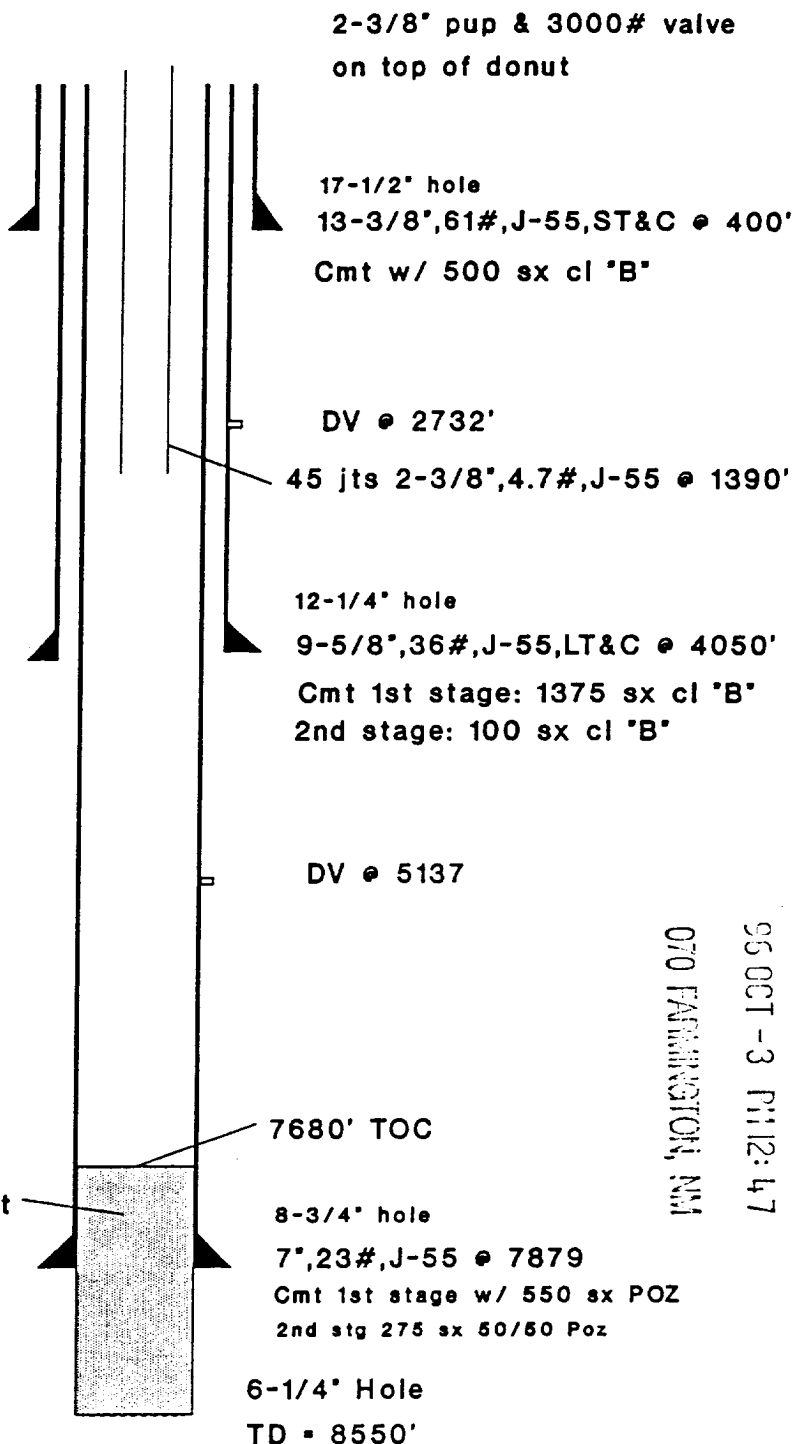
